2. HAZARD IDENTIFICATION

PRIMARY ROUTES OF EXPOSURE: Eye Contact
Skin Contact

EYE CONTACT: Direct contact with this material may cause irritation.

SKIN CONTACT: Prolonged or repeated contact may cause irritation of the skin.

3. COMPOSITION

Acrylic water-based emulsion paints.

4. FIRST AID MEASURES

EYE CONTACT: Flush eyes with large amounts of water before dispersion dries for at least 10 minutes.
Seek medical advice if irritation persists.

SKIN CONTACT: Remove contaminated clothing. Wash with soap and water before dispersion dries.

INGESTION: Drink plenty of water. Do not induce vomiting. Seek medical advice.

5. FIRE FIGHTING MEASURES

Aqueous dispersions will not burn. Dried films are combustible. Material will spatter above 100°C.

FLASH POINT: Non-combustible

AUTO-IGNITION TEMPERATURE: Not Applicable

EXTINGUISHING AGENTS: Water, foam, carbon dioxide or dry powder extinguishers are all suitable.

6. ACCIDENTAL RELEASE MEASURES

Spillage should not be washed into any drain unless it leads to a suitable effluent treatment process. Residues and spillage should be soaked up with an inert absorbent (e.g. sand, earth) for disposal.

7. HANDLING AND STORAGE

HANDLING: Handle in accordance with good industrial safety and hygiene practices.

STORAGE: Keep from freezing; product may coagulate.
Store in sealed containers between 5°C and 30°C.

8. EXPOSURE CONTROLS AND PERSONAL PROTECTION

EXPOSURE CONTROLS: Local exhaust ventilation may be required in circumstances where the product is sprayed, heated or dried in confined spaces.

PERSONAL PROTECTION: Respiratory: If sprayed in confined spaces e.g. indoors, masks may be required.

Hand: Gloves, if risk of skin contact.

Eye: Goggles, if risk of splashing.

Skin: Standard industrial overalls if risk of splashing.
